Below is a brief yet thorough description of how I run my piano teaching business.

Please take some time to become familiar with these terms and conditions. I do find that parents who get to know the way I work, take more from the experience and see better results for their child.

When you've read and absorbed the information, simply sign on the line at the end of the document and bring the signed copy to your next lesson. We can then go through any questions you may have.

#### Section 1: Lesson Schedule and Tuition:

**1a)** Lessons are once a week at my home studio, year round.

**1b)** The parent/student can choose to take a 30min, 45min, or 60min lesson. Once this has been decided, it will be the same duration each week until further notice.

**1c)** The parent/student may choose to change to any other lesson duration at any time throughout the year, with four weeks' notice.

**1d)** All rates are fixed and calculated per semester of tuition and are subject to change over time. Written or verbal notice will be given if they change. Please see tables below for full, current details.

# Section 2: Tuition installments:

**2a)** Tuition, whether paid in full per semester or in monthly installments, are to be made in cash, Zelle (to <u>rhythmandrusso@gmail.com</u>), or card payment (there is a small additional charge for card and PayPal payments).

**2b)** All monthly installments are due on or before the final lesson of the previous month. For example if your child is seeing me for a 30min lesson each week, your monthly payment for September 2023 will be \$215.00 and this will be due on or before the final lesson of August 2023. Please bear in mind that the final lesson of the month may not occur during the final week of the month. For example if there is a holiday or any other form of planned absence.

**2c)** If the monthly installment is not made on or before the final lesson of the previous month as outlined in part 2b, and a good reason for this is NOT offered, a \$20.00 late fee may be added to the month's total.

**2d)** If the monthly installment is not made on or before the final lesson of the previous month as outlined in part 2b, and a good reason for this IS offered, I am happy to extend the deadline with no late fee.

## Section 3: Cancellations:

**3a)** If a lesson is cancelled with at least 48 hours' notice, I am happy to offer a makeup lesson to take place within a week of the cancelled lesson. Please note, this is instead of offering a refund for the cancelled lesson and subject to available time slots. If there are no available time slots the lesson is forfeited.

**3b)** If a lesson is cancelled with less than 48 hours' notice, and a good reason for this is NOT given, there will be no refund OR make-up lesson offered.

**3c)** If a lesson is cancelled with less than 48 hours' notice, and a good reason for this IS given, a make-up lesson will be offered to take place within a week the of the lesson cancelled. Please note, this is instead of offering a refund for the cancelled lesson and subject to available time slots. If there are no available time slots the lesson is forfeited.

**3d)** Good reasons for cancelling a lesson with less than 48 hours noticed include sickness, family emergency etc. Each case will be judged on its own merits and the make-up decision will be at my discretion.

**3e)** If a lesson is cancelled with 48 hours' notice, and in the unlikely event a make-up lesson is not possible that week due to scheduling issues, the cancelled lesson will be forfeited and no refund will be offered. Likewise, if a make-up lesson is scheduled and then later cancelled, the make-up lesson is forfeited and no refund will be offered.

• Please note all make-up lessons, for any reason, are subject to availability and are not guaranteed.

Important dates:

Spring Recital – Saturday February 1<sup>st</sup> (date may change, time tba) Summer Recital – TBA (very likely Saturday June 21st or Saturday June 28<sup>th</sup> )

Observed holidays during semesters and other dates with no lessons:

Fall Break 2024 - tba Thanksgiving 2024 – November 25<sup>th</sup> through the 29<sup>th</sup> Martin Luther King Junior – Monday January 20<sup>th</sup> 2025 President's Day – Monday February 17<sup>th</sup> 2025 Spring break – March 17<sup>th</sup> through March 21<sup>st</sup> 2025 (these dates may change) Memorial Day – Monday May 26<sup>th</sup> 2025 June 30<sup>th</sup> - July 6<sup>th</sup> in observance of independence day 2025

## Section 4: The Summer Semester:

**4a)** During the summer semester (defined as June 2nd - August 22nd), tuition will continue the same as the rest of the year. However, if you have plans to travel we'll

accommodate the tuition to ensure you only pay for the lessons you have during this time (I appreciate that you may have plans to get out of the heat for a week or two, trust me I plan to do the same!)

**4b)** Lessons scheduled for each of the three summer semester months will be agreed upon on or before the 20th of the previous month, in order to give us time to calculate and arrange the tuition. For example if you are travelling for a week in August and can therefore only commit to three lessons during that month, we will confirm the dates and tuition for these lessons, on or before the 20th of July.

**4c)** Please see tables below for all summer semester pay-as-you-go rates. Please note these rates are for summer only.

60min	\$100

## **Additional Notes:**

It is important that lessons continue during the summer semester as this is when your child will have less to focus on elsewhere (i.e. at school) and will therefore be more focused on making solid progress with piano playing. I have found that the students who commit to summer semester lessons see much greater results over the course of the full year.

I understand that it can be a tricky time of year, but it can also prove to be highly productive so I encourage you to consider an active summer lesson schedule!

Let's work together to make sure the learning and development continues during the summer for your child.
